This is an absolute intrusion into the free market and not the proper role of government. The claim is that this bill does not use public funding, but the	
	text of the bill disagrees. The bill explicitly mentions the use of public funds for private property improvements in the context of financing qualifying improvements, including energy efficiency, water conservation, renewable energy, and resiliency improvements on private properties. Lines 329-331 even claim it to be an "essential government function" for public funds to be used in this manner. Lines 337-345 explicitly lay out how public funds may be used saying that counties and municipalities may furnish funds to aid in these endeavors. In lines 346-396 it even discusses the authority for imposing assessments.	
	This bill passed the House purely with Democrat support. A large amount of Republicans voted against this bill because no Republican in their right mind can support this legislation.

During these 14 days, the owner may restrict their ability to use the facility outside of accessing their own personal property. Summary:	This bill adds a statutory maximum to the amount of discrepancy allowed in a risk limiting audit. It further mandates that the race at the top of the ballot is audited along with an additional race. This bill increases the integrity in our elections and the SFCN recommends YES on this bill.

Summary:	This bill would make it a felony with 2-5 years in prison for someone to publish, broadcast, stream, or upload a video recording, video file, audio recording, or audio file, still image, or still image within 90 days of an election that is perceived to be deceptive by means of appearing to be real when it is not. For simpler terms, it would be illegal to post a deepfake or digitally altered image within 90 days of an election if the powers at be claimed it to be intentionally deceiving and having interfered in the election.
	By substitute, the bill certainly has become less bad than it was before. Being executed via hanging, while better than being executed via quartering, is still being executed. Infringing on free speech is still infringing on free speech, regardless of how many parameters you put on it. We have seen it very clearly with Fani Willis this year that it is essential to not create avenues for power to be abused because it then certainly will be.
	The bill now requires these prosecutions to begin with a recommendation from the state elections board. Perhaps for now this will sufficemaybe. If Democrats ever were to get control of the state elections board, that is a scary thought. Even when it comes to the issues in the 2020 election, it was largely Republicans who were the problem rather than Democrats. Now we have a Republican Governor who refuses to acknowledge that there is anything wrong with the actions of Fani Willis, Jack Smith, Alvin Bragg, and so it is clear that even Republican control is not enough to protect Georgians.
	The substitute did narrow the scope of this bill to only apply to any employee, staff member, or other similarly affiliated individual of a political party, political body, candidate, campaign committee, political action committee, or any other



political committee. Narrower is better, but that means still some people are under this umbrella. Perhaps the average person is not employed by a candidate or a PAC, but many are affiliated with a political party, political body, or a candidate. At the end of the day, mere affiliation is required, not employment. A simple Republican Party member who is an activist in their community that posts some memes is still very eligible for prosecution. The bill adds language saving that campaigns may use Al generated images, videos, or audio if it has a disclaimer. The future of AI presents troubling possibilities. If we lose our first amendment in the process of preventing deception, we have lost that which we sought to protect. This bill is a grave risk to free speech, making it where someone could be thrown in prison for something as simple as posting memes that were then deemed to have interfered in an election. For the sake of freedom, the SFCN recommends NO, with the strongest possible emphasis, on this bill. It also clarifies that government vehicles must have plates signifying they are government vehicles. There are existing exemptions, and this bill does not change that. Currently it is largely just pertaining to vehicles used exclusively for government use, but this bill provides transparency by making the people aware of who owns that vehicle. It further allows trailers to be considered as part of a "fleet" which is a group of 100 or more cars (and now trailers too under this bill) for the purpose of registration in bulk. This is things like U-Hauls where the company owns a large amount. The bill makes re-registration easier.

It mandates annual audits for local governments with populations over 1,500 or expenditures exceeding \$550,000, and biennial audits for those not meeting these criteria. Local governments spending less than \$550,000 may opt for an annual report of agreed-upon procedures instead of the audit. Additionally, the bill specifies the content of annual audit reports for county or city-county governments, which must include financial conditions of discretionary funds of county officers. Audit reports must be completed and submitted to the state auditor within specified deadlines, with a requirement for public access to these reports. The bill also outlines procedures for failure to conduct audits or address deficiencies, including public notification and potential withholding of state funds for non-compliance. This bill is good for transparency and the SFCN recommends YES on this bill.
