Sponsor:	Chuck Hufstetler (R-52)
Summary:	This bill creates a statewide homestead exemption set at 3% for ad valorem taxes. There are also some minor administrative changes, and the length of the bill is largely due to the requirement to change the language of notices due to changing to manner by which we approach these taxes. This is a good bill, preventing local governments from using inflation as an excuse to massively increase property taxes like we have seen in recent years. The SFCN recommends YES on this bill.

Summary:	This bill exempts the services of shampooing and blow drying from occupational licensure requirements. The SFCN opposes all occupational licenses. This bill weakens licensing, should go further, but it moves Georgia in the right direction. Therefore, the SFCN recommends YES on this bill.

Governor, and a representative of a public or private defense entity appointed by the Governor. It changes the chair from the Defense Initiative Director to the economic development commissioner. It adds growing the defense industry to the mission statement thereof. This is seemingly an attempt to make our military crony and more concerned about profits for the defense industry than our country's safety. It is an absolute conflict of interest to have those profiting from conflict to be advising on the military. Moving it from TCSG from economic development is for the purpose of increasing funding, turning it more into an economic development commission, seeking ways to use

Less students in university and more pursuing alternate means of being a productive member of society is a good thing and the SFCN recommends YES on this bill.

Summary:	This bill allows the Governor, Lt. Governor, or any member of the General Assembly to request the Office of Planning and Budget and the Department of Audits and Accounts to create a small business impact analysis report on any bill in any session of the General Assembly. These offices would be required to comply with the request. The bill would change the definition of small business from those with less than 100 employees to those with less than 300 employees for the purpose of these reports. It then requires agencies notify the General Assembly of news regulations so that the General Assembly can decide whether or not to overturn the regulation. The bill also bars emergency declarations from lasting more than 120 days. It
	also requires that a process be created for reviewing existing rules and regulations by government agencies to assess whether they are needed or not. This bill presents unbelievable transparency to the actions of government, is one of the best bills to be presented this session, and the SFCN recommends YES on this bill.

Summary:	This bill expands the COVID-19 liability protections to apply to any instance other than those of gross negligence, providing the presumption of assuming to risk for those entering. There will no longer need to be notices or anything of that nature. This is a great bill, preventing lawsuits over ridiculous claims of COVID-19 liability, and the SFCN recommends YES on this bill.

Additionally, the bill specifies the content of annual audit reports for county or city-county governments, which must include financial conditions of discretionary funds of county officers.
